### Alex Connor '18 Dean of Students | North Middle School

#### Describe your current professional or educational pursuits.

# Blake Warner '14, '22, '24

Postdoctoral Fellow (Clinical Psychology) | University of California, Los Angeles

### Describe your current professional or educational pursuits.

I am a postdoctoral fellow in clinical psychology at UCLA in the PEERS (Program for the Education and Enrichment of Relational Skills) clinic. I lead social skills training interventions designed to help neurodivergent teens and adults learn and practice skills related to finding and keeping friends. I also conduct intervention research on programs tailored for neurodivergent adults. Another key aspect of my position is providing clinical supervision for graduate-level trainees, supporting them in refining their therapy and assessment skills.

The foundation of my work is built on the clinical skills I developed during my graduate training at the University of South Dakota (USD), particularly through my experience as a Leadership Education in Neurodevelopmental and Related Disabilities (LEND) trainee at the South Dakota Center for Disabilities. These experiences not only shaped my approach to clinical care but also prepared me to take on leadership roles. I regularly lead certified trainings for professionals, including psychologists, educators and other providers, to expand access to the PEERS intervention, equipping them with the tools to teach social skills to neurodivergent individuals.

I am also passionate about advocacy work. Part of my role includes developing and testing a program for self-advocates with disabilities. The program is focused on teaching advocacy skills, including how to effectively engage with legislators.

Looking ahead, my goal is to increase access to interventions such as PEERS to make it more accessible to a broader audience. I am committed to continuing my work in training professionals to deliver this intervention and ensuring that more neurodivergent individuals can access services. After my fellowship, I plan to pursue faculty status at UCLA.

### How did USD influence your personal and professional experiences following graduation?

USD significantly influenced my personal and professional experiences following graduation. I gained essential clinical skills during my graduate studies at USD, and one of the most impactful experiences was my training as a LEND trainee at the South Dakota Center for Disabilities. This opportunity allowed me to specialize in providing services to individuals with disabilities and their families, which has directly informed my work as a postdoctoral fellow at UCLA.

Through my time at USD, I also developed valuable leadership and advocacy skills that I apply in my current role. My experience as a competitive speaker on the speech and debate team while I was an undergraduate student at USD further shaped my communication abilities, boosting my confidence to speak to diverse audiences and train clinicians.

Moreover, my education instilled in me the importance of collaboration. The liberal arts curriculum in my undergraduate studies and the interdisciplinary training in graduate school fostered my critical thinking and problem-solving skills, allowing me to work effectively with others in both academic and clinical settings.

USD provided me with the tools and experiences that have shaped my career trajectory and personal growth, reinforcing my commitment to advocating for and supporting individuals with disabilities and their families.

### How have you demonstrated success and influence in your profession and community?

I have demonstrated success and influence in my profession and community through my active involvement in research, training, and advocacy. Currently, I am part of the research team examining the effectiveness of the PEERS for Dating intervention, which focuses on teaching neurodivergent young adults the skills necessary for finding and maintaining romantic relationships. Notably, content from this intervention has been featured in the show *Love on the Spectrum*, highlighting its real-world relevance and impact.

As a PEERS-certified trainer, I am qualified to teach other mental health professionals and educators how to effectively lead the PEERS intervention. I have conducted trainings for up to 250 providers at a time, significantly increasing the accessibility of this vital intervention for neurodivergent individuals and their families.

In addition to my training efforts, I have been invited to speak at various universities and organizations on disability and advocacy-related topics, allowing me to share my insights and experiences with a broader audience. My recent completion of the Emerging Leader Fellowship with the Association of University Centers on Disabilities (AUCD) enabled me to collaborate with interdisciplinary trainees from across the country, further amplifying my influence in the field.

I also present research nationally and internationally, including a recent presentation at the International Society for Autism Research in Melbourne, Australia. I am deeply committed to providing clinical services and disseminating important research findings, which not only contribute to the academic community but also improve the lives of those I serve.





# Bre Schmidt '20

Associate Director of State Government Affairs | American Osteopathic Association

### Describe your current professional or educational pursuits.

I play an active role in shaping healthcare policies that impact osteopathic physicians and their patients. My daily work involves monitoring state legislation, developing strategies to advance our priorities and collaborating with state osteopathic medical associations.

I rely heavily on skills like policy analysis, strategic communication and relationshipbuilding. Navigating the ever-changing landscape of healthcare policy means I need to stay up to date on emerging issues, craft persuasive arguments, and effectively communicate our positions to lawmakers and regulatory bodies.

My education in health service administration from USD has been a game-changer. It provided me with a solid foundation in understanding healthcare systems and how policies are developed. In addition to my coursework, my internship at Avera Health truly brought my education to life. Working under CEO Ashli Danilko and shadowing Deb Fisher-Clemens, the vice president of public policy, was an incredible experience.

This experience ignited my passion for bridging the gap between healthcare providers and policymakers. I'm dedicated to advocating for laws and regulations that enhance patient care and support the osteopathic profession. My goal is to continue influencing policy to improve healthcare delivery by helping draft policies and monitoring new programs and initiatives being implemented at both the state and international levels.

### How did USD influence your personal and professional experiences following graduation?

Graduating from USD in 2020 was both exciting and challenging, especially with the world in upheaval due to the pandemic. Moving to Washington, D.C., during such uncertain times was daunting, but the solid foundation and valuable connections I made at USD gave me the confidence to take that leap. The mentorship and support from my professors and healthcare executives opened doors I hadn't imagined.

Thanks to these relationships, I had the opportunity to work on Capitol Hill with Senator Thune, where I witnessed firsthand how healthcare policy is shaped at the national level. This experience was instrumental in shaping my professional path. The skills and knowledge I gained from USD were directly applicable, allowing me to contribute meaningfully despite the challenges of the pandemic.

Although my participation in the field program in Cuba occurred during my time at USD, its impact extended well beyond graduation. Researching Cuba's socialized education and healthcare system sparked a passion for global health policy that continued to grow. This experience influenced my decision to delve deeper into global health after graduation. Motivated by this passion and my experiences in D.C., I decided to further my education. I returned to school and graduated with a Master of Public Health in global health policy in August 2023. ### **Caitlyn Lint '18, '21** Assistant Professor of Practice | USD Department of Dental Hygiene

### Describe your current professional or educational pursuits.

I graduated from USD with my bachelor's degree in dental hygiene in 2018 and again in 2021 with a master's in public health. In my own clinical practice, I primarily work in Sioux Falls where I have worked in a variety of settings. I am currently in my third year of teaching in the dental hygiene program at USD. I serve as senior clinic coordinator, where I get to work closely with our students as they continue their clinical journey, prepare for their national board exams and explore the beginning stages of their careers. One of my favorite aspects of this job is seeing my students blossom not only as clinicians, but as human beings. ### Describe your current professional or educational pursuits.

### How did USD influence your personal and professional experiences following graduation?

# Collette Bowman '17, '24

Clinical Psychology Trainee | Lewis and Clark Behavioral Health Services - Ebel Recovery Center

### Describe your current professional or educational pursuits.

I am deeply engaged in community mental health and provide peer mentoring services to Native American undergraduate students at USD. As a Native American woman pursuing a doctorate in clinical psychology, I leverage my unique positionality to build representation and support for students navigating higher education. My position entails developing and facilitating programs that promote mental health awareness and resilience among Native American youth, fostering an inclusive environment where they can thrive academically and personally.

Among the programs I have implemented are Talking Circles, rooted in traditional Lakota practices, which I facilitate with colleagues to create safe spaces for students to share their experiences and support one another. Additionally, I serve as the program coordinator for the Iwacinyechi Peer Mentoring program, where I help connect students with mentors who can guide them through their academic journeys and personal challenges. In this capacity, I utilize a range of skills, including active listening, cultural competence and effective communication, to connect with students and understand their individual experiences. I also draw upon my training in psychological principles to create supportive spaces that encourage open dialogue about mental health and identity. My role emphasizes the importance of empathy and insight, allowing me to approach each student's narrative with care and understanding.

Through my educational pursuits, I aim to accomplish several goals. Primarily, I hope to encourage more Native American youth to attend college by providing mentorship and resources that empower them to succeed in their academic journeys. I am planning a conference that will bring tribal schools to USD, offering students the opportunity to explore the university and learn about the field of mental health through interactions with other Native scholars and clinical psychology students. Ultimately, I aspire to contribute to a broader movement that elevates Native voices in academia and mental health, fostering a more inclusive and supportive educational landscape.

# How did USD influence your personal and professional experiences following graduation?

The University of South Dakota profoundly influenced both my personal and professional experiences following graduation. The support I received during my undergraduate years laid a strong foundation for my journey in higher education and beyond. Through leadership opportunities within the Tiospaye Student Council, the President's Board, and the American Indians in Science and Engineering Society (AISES), I developed essential skills in advocacy, collaboration and cultural understanding. ### How have you demonstrated success and influence in your profession and community?

I have demonstrated success and influence in my profession and community through my dedicated efforts in community mental health and educational advocacy for Native American students. As a program coordinator for the Iwacinyechi Peer Mentoring program, I have worked to create a supportive network for Native American undergraduate students at USD. This program connects students with mentors who guide them through their academic journeys, helping to empower them. In addition to mentorship, I have presented posters and panels discussing the importance of cultural knowledge within mental health. my presentations illustrate how Talking Circle were developed using a community participatory approach and explore their potential implementation on other campuses. These discussions emphasize the need for culturally relevant mental health practices that resonate with Native American experiences and values, promoting holistic well-being.

Within my department, I actively advocate for the recruitment of Native students through inclusive practices. I served on the clinical training committee where I championed the importance of integrating cultural competency into our curriculum. As a direct result of these advocacy efforts, a dedicated course on cultural competency is now offered, enriching the training of future mental health professionals and ensuring they are better equipped to serve diverse populations.

Furthermore, I advocate for fairness and transparency from faculty regarding departmental changes, ensuring that all students are informed and have a voice in these processes. I believe that open communication fosters trust and collaboration within our academic community. At my clinical sites, I am recognized for providing strong therapeutic support, enabling clients to receive the comprehensive care and resources they need. my commitment to cultural understanding and advocacy for Native American students has significantly influenced my peers and the broader communities, fostering an inclusive environment that values diverse perspectives. By actively engaging in these various roles, I strive to promote a culture of equity and respect, ultimately paving the way for future generations of Native American leaders.





# **Epiphany Knedler '17**

**Co-Founder & Curator | Midwest Nice Art** 

#### Describe your current professional or educational pursuits.

I am the curator and co-founder of Midwest Nice Art, an arts organization based in Aberdeen, South Dakota. Grounded in traditional Midwestern values, the collective integrates virtual and physical practices to support emerging and underrepresented artists. The name reflects Midwestern cultural stereotypes of polite passiveaggressiveness, which we have reclaimed to foster a community based on respect, collaboration and inclusion. Beginning in 2022, my husband, Tim Rickett, and I found a lack of access and opportunities for emerging artists. With our background in education and being artists ourselves, we provided a space for artists to share their work. I believe that we are closely aligned with acts of service in the arts. Many artists in the rural Midwest lack access to contemporary art in their local communities. We work to provide artists with the resources to not only share their work but feel confident in doing so. We provide free professional practice resources, studio visits and exhibition opportunities. Rather than supporting the "brain drain" the Midwest often struggles against, we want to reverse the trend and bring creatives to our communities. In Spring 2024, we collaborated with treat gallery to curate a booth for the Affordable Art Fair in New York City. Over half of the artists included were from the Midwest.

Curation requires skills in organization, design, aesthetic awareness, marketing and communication, research and management. We recently hosted our second annual exhibition, nice;02, an exhibition hosted in Aberdeen featuring the work of over 50 artists. For many organizations, this is a substantial task, but deploying the leadership, management and professional practices I learned at USD, I can bring these experiences to life.

I also serve as a Lecturer of Art at Northern State University, an online instructor at USD, and the Content Editor for *Lenscratch*, a contemporary photography magazine. Each of these positions require a strong dedication to supporting others. I believe that, as a Midwesterner, commitment and enthusiasm were instilled in me at a young age. I continue to dedicate my professional practices to providing education and opportunities for others.

# How did USD influence your personal and professional experiences following graduation?

USD transformed my passions and professional practice. Before attending USD, I was solely going to major in political science, imagining myself working in the government. After taking an art history class with Dr. Sarah Sik and an art class with professor Michael Hill, I decided to double-major in political science and art. The art and political science departments taught me how to use my voice to create change and advocate for others.

After graduating with a BFA in studio art and a BA in political science, a truly unconventional combination, I wanted to dedicate my time to supporting others in their creative careers. I pursued my MFA in studio art at East Carolina University. The MFA is the terminal degree for anyone in the arts, giving me the ability to teach in higher education, review and provide grant opportunities, expand research skills and grow my professional career. USD prepared me to take on new responsibilities, teaching undergraduates and completing my thesis.

While at USD, I was the College of Fine Arts representative in the Student Government Association and on the finance committee, the president of the Student Art Alliance, in the honors program, student career ambassador, Amnesty International and Pi Sigma Alpha, the National Political Science Honors Society. I presented my research at two IDEAfest competitions and received a CURCS Grant, which allowed me to win the ECU Research and Creative Achievement Award in the first year of my MFA. These experiences allowed me to take on leadership roles like public relations coordinator at the Oscar Howe Summer Art Institute, graduate liaison for the School of Art + Design at ECU and president of the Graduate Arts Forum. My experience at USD provided the necessary leadership and management opportunities to start an organization in the arts.

I'd like to thank the art department, Student Government Association, the honors program, and the political science department for instilling these skills within me and supporting my efforts into the future.

### How have you demonstrated success and influence in your profession and community?

My creative and professional practices have flourished since my time at USD. I cofounded Midwest Nice Art in 2022; our community has grown to include over twothousand artists from around the world, exhibited over 500 artworks, collaborated with 12 professionals in jurying exhibitions and curated one art fair booth. In 2025, we will be providing two \$500 grants and hosting five virtual exhibitions and two in-person exhibitions. Midwest Nice Art has been selected as a guest curator for an exhibition at StoveWorks in Chattanooga, TN, in 2025, which will feature many USD alumni.

I also work as a lecturer of art at Northern State University and Cramer Center for Design & Innovation Fellow. I have been teaching in higher education for six years. I serve on the College Art Association Student and Emerging Professionals Committee, a national committee that provides resources for emerging professionals in the arts who are interested in higher education. Recently, Midwest Nice Art's resources have been adopted as the national standard. This work allows me to continue to share my love of art and instill exceptional creative practices in my students.

Within my personal practice, my work has been published in the *New York Times* and featured in the *ARTNews Daily Review*. My work was awarded an Honorable Mention for the Lucie Fine Art Professional Scholarship and a Photolucida Critical Mass Finalist. I recently exhibited "Wish You Were Here" at the Vermont Center for Photography and a collaborative exhibition "Here in the Mysterious Elsewhere" with Tim Rickett in the John A. Day Gallery at USD. I have exhibited in over 150 group exhibitions and been awarded over ten grants. My professional career thus far has been very fulfilling, and I am excited to continue my work supporting others and sharing my impressions with them in the future.





# Garrett Keegan '20

Associate Attorney | Costello, Porter, Hill, Heisterkamp, Bushnell & Carpenter, LLP

#### Describe your current professional or educational pursuits.

I am in my third year as an associate attorney for Costello Porter. My practice area is quite broad and includes general civil litigation, criminal defense, and I am a special prosecutor for the Cheyenne River Sioux Tribe. Myself, along with another attorney in our firm, also serve as defense attorneys for the Pennington County Veterans Court program. No two days are ever the same, and it is something I have come to enjoy. My job requires me to have great communication skills; I am either writing briefs to the court, advocating for my client's position, or I am speaking with clients and explaining what I believe are the best options for them.

# How did USD influence your personal and professional experiences following graduation?

The USD Knudson School of Law taught me the importance of community and how building strong relationships with your colleagues and professors can be incredibly beneficial. South Dakota has a relatively small legal community, so continuing to speak with my former classmates and my professors about different developments in the law or practice areas that I'm not as well versed in has been very helpful. Furthermore, cases can oftentimes be contentious and your client may have a very adverse position compared to the opposing party. Knowing the attorney on the other side and remaining civil with them while advocating for your client's position throughout the case not only makes the case go smoother, it can greatly benefit the client as well.

# How have you demonstrated success and influence in your profession and community?

I have demonstrated success and influence in the profession by continuing to grow as an attorney after law school. As mentioned, I am one of the defense attorneys for the Pennington County Veterans Court program, which has been an amazing way to help Veterans protect their rights while working through an intensive probation program as opposed to going to prison. Seeing their progress firsthand has been very rewarding. I have demonstrated success and influence in the profession by continuing to grow as an attorney after law school. I have enjoyed watching my little brother grow into a respectful and kind young adult while we break up the monotony of his school work and my work by doing fun activities in the Black Hills.





# **Jacob Selgestad '19**

Senior Analyst | Government Accountability Office

#### Describe your current professional or educational pursuits.

I currently serve as a senior analyst with the Science, Technology Assessment, and Analytics (STAA) team within the Government Accountability Office (GAO). My role involves conducting research and reporting on government programs and other key issues on behalf of Congress. My research is currently focused on intellectual property issues and the United States Patent and Trademark Office.

Serving as a policy analyst requires a number of different skills. I get plenty of opportunities to conduct different kinds of data analyses, which allows me to use my quantitative skills I developed while studying economics at USD. But other key tasks an analyst must carry out, like expert interviews, report writing and giving presentations allow me to use the more qualitative skills I developed while studying political science at USD.

I find meaning in my current role due to my strong belief that government agencies and Congress need factual information to make informed decisions. ### How did USD influence your personal and professional experiences following graduation?

Programs like the Farber Fund allowed me to work in a diverse array of internships during my time at USD. These internships helped me figure out what I would be interested in doing for a career, while also helping me develop a robust resume and set of skills that set me apart during the application process for graduate school and the workforce.

University of Nevada, Reno

#### Describe your current professional or educational pursuits.

As a PhD student in integrative neuroscience and MS student in kinesiology at the University of Nevada, Reno, I am pursuing a multidisciplinary approach to understanding sports performance and the effects of sports on brain function. My role as the assistant director of operations in the Neuromechanics Lab allows me to blend my passion for sports with cutting-edge neuroscience research. My position involves conducting innovative studies on mild traumatic brain injuries (mTBIs) and their long-term effects, particularly in athletic contexts. I utilize advanced technologies such as instrumented mouthguards and customized neurocognitive assessments to examine head impact kinematics and track mTBI recovery. My research on Guardian Caps has recently been featured in multiple newspapers, online journals and podcasts, most notably on CNN.

In my role as a researcher, I employ a diverse skill set including experimental design, statistical analysis and scientific writing. I've contributed to multiple publications examining concussion assessment tools and the effectiveness of protective equipment in reducing head impacts. These studies require meticulous attention to detail, critical thinking and interdisciplinary collaboration.

My work has been recognized with several prestigious awards, including the Nevada Outstanding Graduate Researcher Award and the UNR Graduate Dean's Merit Scholarship. These accolades reflect the impact and innovation of my research in the field of sports neuroscience.

Complementing my research, I serve as an assistant coach for the Division I swim team at the University of Nevada, Reno. This position allows me to apply my research findings directly to athlete performance and safety, bridging the gap between theory and practice. This role also ties into my time as a two-time captain of the USD's swimming and diving team. Looking ahead, I aspire to contribute significantly by developing innovative approaches to concussion management and rehabilitation, potentially revolutionizing how we understand and treat sports-related brain injuries. I'm also committed to mentoring the next generation of researchers and athletes, whether that be through mentorship programs or coaching roles. My unique combination of academic expertise and practical coaching experience positions me to drive meaningful advancements in the intersection of neuroscience and athletics.

### How did USD influence your personal and professional experiences following graduation?

My experience at USD profoundly shaped my personal and professional trajectory. As a student-athlete on USD's swim team, I developed crucial leadership skills and learned to balance rigorous academic pursuits with athletic commitments. Serving as women's team captain for two consecutive years (2020-2022) honed my ability to motivate and guide others, skills that continue to serve me well in my current roles as an assistant coach at the University of Nevada.

Academically, USD provided me with a strong foundation in cognitive neuroscience. Maintaining a 3.75 GPA while consistently making the dean's list from 2018-2022 demonstrated my dedication to academic excellence. The recognition I received, including Academic All-Summit League honors and the Summit League Commissioner's List of Academic Excellence, reinforced the importance of balancing athletics with academics, a principle I now instill in the athletes I coach.

My research experiences in two labs at USD were particularly influential in shaping my professional path. In the Peterson Lab, I worked on projects including the development of a self-contained wearable EEG and neurofeedback training for athletic performance. This experience sparked my interest in the intersection of neuroscience and athletics, which is now central to my graduate research. As an undergraduate research assistant in the Memory and Attention Laboratory, I contributed to projects on visual working memory and physiological measurement of time and interference effects in working memory. These experiences provided me with valuable skills in experimental design and data analysis, preparing me for my current graduate studies. The mentorship and opportunities I received at USD, such as being selected for the President's Senior Leadership Institute and receiving the UDiscover Summer Scholar award, were instrumental in shaping my path toward becoming a researcher and leader in the field of sports neuroscience.

USD provided me with a unique blend of athletic, academic, and research experiences that have directly influenced my current pursuits in integrative neuroscience and kinesiology, setting the stage for my ongoing contributions to the field of sports-related brain research.

### How have you demonstrated success and influence in your profession and community?

Since graduating from USD, I've demonstrated success and influence in both my profession and community through groundbreaking research, media recognition and academic achievements. My research on Guardian Caps and head impact kinematics has gained significant attention in the scientific community and beyond. This work, which examines the effectiveness of protective equipment in reducing head impact, has been featured in multiple newspapers, online journals, and podcasts. These media appearances have allowed me to share important findings about athlete safety with a broad audience, influencing public awareness and potentially impacting sports safety protocols.

Academically, my success is evident through several prestigious awards. I was honored with the Nevada Outstanding Graduate Researcher Award, recognizing me as one of 13 graduate students performing outstanding research at the University of Nevada. Additionally, I received the UNR Graduate Dean's Merit Scholarship, a competitive one-year \$10,000 award for which I was nominated by the Integrative Neuroscience Program Directors. These accolades reflect the quality and impact of my research in the field of sports neuroscience.

My influence extends to the classroom and athletic arena as well. As an assistant coach for the Division I swim team at Nevada, I directly apply my research findings on the postural dysfunctions seen in collegiate swimmers to enhance athlete performance and safety.

In the research community, I've contributed to multiple publications examining concussion assessment tools and the effectiveness of protective equipment. My work on the minimal detectable change for the ImPACT test and the preliminary examination of Guardian Cap head impact data using instrumented mouthguards has been published in respected journals like the *Journal of Athletic Training and the Archives of Clinical Neuropsychology*.

Furthermore, I've taken on leadership roles within the academic community. As a cofounder of the Integrative Neuroscience Doctoral Program Colloquium, I've worked to create opportunities for knowledge sharing and collaboration among PhD students. I am also a mentor to Indigenous undergraduate students at Nevada.

Through these achievements and roles, I've demonstrated a commitment to advancing knowledge in sports neuroscience, improving athlete safety, and sharing valuable insights with both academic and public audiences.



### Lauren Paul '23 Opera Singer

#### Describe your current professional or educational pursuits.

I am an emerging artist in the opera world. Since 2022 during my time at USD, I have been applying for young artist programs (YAPs) and have been invited to audition for some of the nation's top YAPs, while having been invited to participate in high caliber programs such as the Gerdine Young Artist apprenticeship program at Opera Theatre of Saint Louis (summer 2024) and the Sarasota Opera studio artist program (winter 2025). My almost 10 years of vocal training, acting training, and performance experience have prepared me to continue to audition for high-profile YAPs this fall during the 2024 audition season and have garnered me an exciting opera season in 2025, as I will be making two mainstage debuts with nationally-recognized opera companies in the spring.

### How did USD influence your personal and professional experiences following graduation?

My time at USD was deeply integral to my emergence as a young opera singer. Going into my masters, the professional world of singing was a mystery to me. My teacher, Dr. Tracelyn Gesteland, was paramount to my development as a young artist. I never thought that a performance career would be feasible or possible. Following Dr. Gesteland's advice, I learned as much about performing, healthy vocal technique and the young artist track as I could. Dr. Gesteland also introduced me to the vocal competition circuit, where I've found a great deal of success.

In 2021, I won the South Dakota Music Teachers National Association (MTNA) state level competition and progressed to the regional level. I was also encouraged to participate in the National Student Auditions for the National Association of Teachers of Singing (NATS) all three years that I attended USD. My final year (2023), I was selected to sing in the final round of the competition live in San Diego, California, where I placed third overall in my category. Without Dr. Gesteland's support and guidance, I would never have been able to participate in competitions like these which have greatly helped me to establish my footing in the opera world postgraduation. Frankly, I would not be the singer that I am today without USD or Dr. Gesteland.

### How have you demonstrated success and influence in your profession and community?

Since graduating from USD, I have found a great deal of success in the opera world. In January 2024, I was selected as a winner of the Nebraska District of the Metropolitan Opera Laffont Competition, an annual competition for North American singers hosted by the Metropolitan Opera in New York. Following my win in the Nebraska district, I advanced to the Upper Midwest Regional competition in Minneapolis where I received an encouragement award. From late April to the end of June this year, I was in St. Louis at Opera Theatre of Saint Louis (OTSL) as a Gerdine Young Artist (GYA). This apprenticeship is highly competitive--of an applicant pool of 1,100 singers, I was one of 28 selected to participate in the program. While at OTSL, I sang in the chorus for productions of Puccini's La Boheme and Handel's Julius Caesar, covered the roles of Cornelia in Julius Caesar and Scribe/Maria Maddalena/Ensemble in Philip Glass's Galileo Galilei, performed in the GYA Center Stage concert with the Saint Louis Symphony Orchestra, and participated in coaching and industry audition days with accomplished professionals in the opera industry.

Following singing on an industry audition day, I was offered a contract to be a studio artist with Sarasota Opera in Sarasota, Florida in early 2025. In addition to duties as a studio artist, such as outreach events and singing in the chorus for Mascagni's Cavalleria rusticana, I will also be making my mainstage debut with the company as Marcellina in Mozart's Le nozze di Figaro in March 2025. In June of 2025, I will be making my debut a little closer to home as Rita the Rat in Tobias Picker's Fantastic Mr. Fox with Opera Omaha.

I currently have my LMSW and in early 2025 will be eligible to test for my LCSW, which is independent licensure and will expand my employment options. Once I am independently licensed, I hope to work primarily with young adults and exploring a university setting, as my own therapist on the USD campus was so helpful in helping me manage my anxiety and inspired me to pursue this path.

# How did USD influence your personal and professional experiences following graduation?

When I graduated I was determined I would not go to graduate school. Through the experiences I had from my counseling internship, skills I learned through the psychology lab and memories I had from a healthcare focused study abroad trip, I concluded that I wanted to expand my opportunities to be able to help others. Thanks to these experiences I had with USD and having time to reflect on them, I went on to obtain my MSW from LSU and graduated in 2022. The previously mentioned experiences and skills I had developed greatly assisted me to excel in the MSW program, graduating with a 4.26 GPA and then passing my licensure exam on my first try. USD is also important to me because it is so close to home and helps me to remember where I came from.

# How have you demonstrated success and influence in your profession and community?

I have been grateful to have successfully discharged several dedicated clients. While I hope I had an impact, the individuals deserve all the credit for doing the hard work.
